  - Execute new data collection on timely topics and in support of growth areas
  - Collaborate with Company Services team on data collection outreach and requests
- Strengthen crucial dataset and assist with research and data analysis. Support production of annual releases and ad-hoc research, data, analysis and survey projects across the CECP team
- **Deliver digital data insights.** Capitalize on existing data visualization platforms as well as custom-built system for CECP companies; opportunity to continually explore new tools; ensure data is delivered with strong attention to data security
- Support growth and maintenance of CECP's Valuation Guidance. Maintain materials, answer company questions, conduct landscape analysis, expand Guidance for growth, and provide trainings
